**Legislative, Financial and Health News (summarized from FEDWeek Bulletins and NARFE Legislative Hotlines):**

**Congress:** On March 17<sup>th</sup>, a bipartisan bill was introduced in the House which would allow military and federal employees to invest the cash value of their unused annual leave into their TSP account. This is similar to a provision extended to private sector employees via a regulatory change announced by President Obama in September 2009. NARFE president Baptiste said it was a matter of equity. Making the change in the TSP requires passing legislation, not just regulations. Total contributions would still be subject to limits,

which for this year are \$16,500 plus another \$5000 for those age 50 or over.

The Senate has rejected a bid to create a special 'one-time' \$250 payment to retirees as a sort-of make-up for the lack of a COLA earlier this year in Social Security, federal retirement and other governmental retirement programs. The Senate refused to add it to another bill, saying it didn't meet requirements for 'emergency spending' covered by the bill. A similar payment ordered last year as part of the 'stimulus' provided \$250 through either Social Security or a tax credit.

Also, no action has happened on a 'hold harmless' provision for enrollees in Medicare. That provision generally states that in a year when there is no Social Security COLA, as this year, Medicare Part B premiums must be frozen as well, but it doesn't apply to those not eligible for Social Security benefits (and others), including CSRS retirees. Their monthly premiums went up more than usual to help pay for benefits for those eligible (\$110.50 vs. \$96.40). There has been no movement on the idea since the House passed an extender bill last fall, and applying the provision retroactively could be very difficult in the budget process.

**CPI/COLA News:** The CPI-W for February is essentially unchanged from January. For purposes of calculating the next COLA, the index is still 1.4% below the 2008 third-quarter average (due to deflation in the past year, this average is still the point of comparison). Benefits awarded under FECA are adjusted on a calendar year basis, and the January index is 0.4% higher than December, 2009.

**TSP Funds:** The TSP stock-oriented funds and the lifecycle funds heavily weighted in stocks posted very good 12-month returns through February as that month displaced the last month of the sharp market downturn of late 2008 and early 2009 in the count. The small company S-fund was up 67.44% for the year and 4.89% for February. The international I-fund up 56.07% for the year and 0.06% for February. The large stock C-fund was up 53.84% for the year and 3.11% for February. The bond F-fund was up 0.38% and government securities G-fund up 0.24% in February with yearly gains of 9.4% and 3.12% respectively. The February and 12-month returns for the life-cycle funds are: Income, 0.74 & 13.05%; 2010, 0.81 & 16.67%; 2020, 1.6 & 33.95%; 2030, 1.94 & 41.0%; 2040, 2.18 & 47.08%.

The TSP has sent out a reminder for those affected by the tax code's 'minimum distribution' requirement (70½ or older with an active TSP account). The requirement to withdraw an amount from the account was waived for 2009, but still in place for 2010. You are required to receive your required minimum distribution by December 31, 2010 or your account may be declared 'abandoned'! Beware!

Note to members: Dues Withholding saves the national organization money and it saves you about \$4.40 over annually paid dues (\$30.60 national plus chapter vs. \$35.00). You don't have to remember to write that check or risk being dropped. **64%** of our members required to pay dues are already using withholding, why not you?
