**Legislative, Financial and Health News (summarized from FEDWeek & GEMS Bulletins and NARFE Legislative Hotlines):**

**NARFE:** President Joseph Beaudoin issued a special message: "NARFE Responds to Attacks on Federal Workers and Retirees" on page 38 of the March NARFE Magazine.

**Congress:** The FY2012 budget submitted by President Obama to Congress on February 14 recommends freezing federal civilian salaries for the second year in a row and cutting non-defense discretionary spending by \$400 billion from a five-year freeze in that area. Plans to reduce federal civilian retirements and health benefits suggested in the December 2010 Fiscal Commission report were not included in the budget

The Federal community won a victory on February 19 when an amendment to the two-year pay freeze offered by Rep. Darrell Issa (R-CA) was defeated by a bipartisan vote. It would have gone beyond the current freeze to also ban merit-based step increases.

March 4 is the deadline for Congress and the President to agree on a further continuing resolution to fund the government. House speaker Boehner has proposed a two-week extension with relatively modest spending reductions. Senate majority leader Reid signaled the Democrats would look for new cuts below the spending freeze proposed by the President. If a partial shutdown should occur, as in the 1995-1996 shutdown, annuity payments would continue and "essential" personnel would continue working.

As many of you know, your federal tax withholding probably increased in your first checks for 2011. This is due to the "Making Work Pay" credit (in the Stimulus Bill from February, 2009) was allowed to expire, unlike the Bush-era tax cuts, which were renewed. As a reminder, federal annuitants receiving payments from OPM can change their tax withholding amounts for both federal and state taxes by contacting OPM on the phone (1-888-767-6738) or using Services Online at [www.opm.gov/retire](http://www.opm.gov/retire). It is suggested retirees use the OPM on-line tax withholding calculator at the same site to avoid under-withholding. NARFE members who are unhappy about the expiration of the Make Work Pay credit should direct their complaints not at OPM but to their own representative and senators (whatever good that will do!).

**TSP Funds:** TSP investors may begin investing into the new 'L 2050' fund through new or transferred funds. It replaces the expired 2010 target date fund, which has been combined with the Income fund. The 2050 fund is the most aggressively invested fund, with the other targeted funds becoming more conservative as their target date approaches.

**Health Benefits/Medicare:** The Open Season for the FLTCIP long-term care program that begins April 4 will run through June 24, not May 27 as previously announced. During that period, current employees, their spouses or same-sex partners who meet certain qualifications may use a shortened form of underwriting, but most will need to use the long application that asks more questions about health and lifestyle.

FECA beneficiaries would be automatically switched to regular retirement benefits upon hitting age 65 under a proposal (S-261) by Sen. Collins (R-ME). Many have criticized the injury compensation program as having become a de facto retirement program that continues to pay benefits at a higher rate than the standard program long after it is clear the beneficiary will not return to work. The White House budget proposal contains a similar recommendation.

**Other Pay Issues:** The count toward the January 2012 retirement COLA now stands at a +0.4%, crossing into positive territory for the first time in

two years. What effect this has on the two-year freeze in salary and benefits is yet to be known. This increase in the CPI-W was mostly due to increases in prices for food and fuel.

About the Social Security tax rate reductions: Above the Social Security maximum, FERS employee contributions to Social Security stop, but contributions by CSRS-offset employees will continue at the standard 7% rate, since all contributions above that threshold go into the federal retirement fund. The payroll tax reduction also doesn't apply to pure CSRS employees; employee organizations tried, but failed, to get the tax break extended to them as part of a tax law passed in January. (CSRS employees don't pay into Social Security; instead, they pay 7% into the civil service retirement fund on all salary. In addition, all employees pay 1.45% into Medicare.)

Note to members: Dues Withholding saves the national organization money (no bills to mail out) and it saves you about \$4.40 over annually paid dues (\$30.60 national plus chapter vs. \$35.00). You don't have to remember to write that check or risk being dropped. **64%** of our members required to pay dues are already using withholding, why not you? Applications are on the NARFE website: [www.narfe.org](http://www.narfe.org).

**Reminder:** Please send us your **"Best Choice"** UPC codes when you get a bunch! (It's not worth using 44¢ to mail one or two!) We get \$30 per 1000 codes (3¢ per code), plus an additional \$30 bonus once a year. The money goes to Alzheimer's Research. Send them either via a member you know who goes to the meetings or to the address in the return address block. Remember, we need only the bar codes, not the whole label. Saves \$.
