

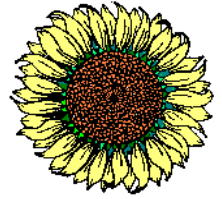

Byron Nichols read the names of the 27 deceased, with flower placement by Christine Leaf and Ernestine Smith. "In the Garden" was then sung by the group. Eulogy was given by president Regina Barger. The business meeting started at 1:15 pm with the usual prayer and Pledge of Allegiance. Wanda Collins was the acting Recording Secretary. Birthday greetings were sung to Bob Horseman. Minutes of the prior meeting were read and accepted. Correspondence were read. There was no Treasurer's report (I left it on my printer, oops!). Bills were ratified. The group voted to change the Memorial Service to the April meeting prior to the State Convention. This means only one list will have to be produced for the same time frame instead of one for the November meeting and one for the convention. Also, we hold the annual Josef Meditz Memorial Luncheon then, and many more members would attend for the remembrance.

The usual drawings were held: #14, Regina Barger, won the \$5 attendance drawing and ticket #480023, Christine Leaf, won the \$5.25 share of pur-

chased tickets. Both were contributed to the Alzheimer's fund. A total of \$18.78 was collected for Alzheimer's this month (Bingo, tickets and attendance prize from the chapter). So far this year the chapter has sent **\$362.58** to the Kansas Federation Alzheimer's coordinator (or, about \$1.34 per official member).

There will be a very short or no formal business meeting.
