NARFE DUES Referendum – Agnes Shellhammer

Hello fellow NARFE members. I haven't written anything for the newsletter for some time, but I can't resist this time. I'm sure you all know about the NARFE dues referendum coming up this fall. It is very important for all of us to understand how it will affect all of us. We would not have National and Chapter dues. There would be only one dues of \$40.00 instead of two. For Shawnee Mission Chapter the change will be a slight increase. Our dues at present are \$29.00 for National and \$9.00 for Chapter dues, for a total of \$38.00. Legislative News by Louis Bornman

Grass-Roots Advocacy Month

Grass-Roots Advocacy Month – formerly known as “Lobby Month” - is the time of the congressional summer recess, August through Labor Day, September 7. This is the prime time recommended by NARFE Headquarters for making visits with every Member of Congress (our Congressman Dennis Moore and two Kansas Senators, Pat Roberts and Sam Brownback) to discuss NARFE issues with them and to personally solicit their support. I am looking for members who can relate personal stories that reflect how some of the issues (like GPO and WEP) negatively impact current active members and/or retirees and how the NARFE supported legislative action would make a positive change for them. I would like to get those personal stories documented and ask those who can to participate in direct meetings with Congressional Members to gain their support for our legislative agenda.

Remember that from time to time our elected officials do hold public meetings with their constituency where they invite people they represent to meet with them briefly to present their concerns over legislative issues they are considering. These are also opportunities for you to express your views on NARFE issues and seek their legislative support. If you go to one of these events please let me know how things went.

If you can not make a personal meeting then I highly encourage you to go to the national NARFE website Legislative Action Center and send our representative and two senators a message (or several) asking them to support our legislative agenda items. If you could also let me know if you do this I would appreciate it also. I would like to be able to use that as leverage when I communicate with our legislators and with other chapters and our state federation. Our chapter is the largest in the state with over 800 registered members. If we **ALL** speak up we can make our issues heard and do a lot to influence our legislators to support those issues.

Issues Affecting Active Federal Employees

There are some issues you may not be aware of that affect active federal employees. The Senate Veterans Affairs (VA) Committee has approved a bill (S-252) that would raise salaries for nurses, physicians, dentists and executives who work for the VA system, while streamlining those pay systems, clarifying policies regarding work scheduling and overtime, and improving education benefits for current and prospective VA

employees. In addition, the measure is designed to make it easier for VA to hire and retain part-time nurses and allow full-time nurses to transition to part-time work schedules, and provide incentives to retired employees to return to the VA.

TSP - Several improvements to the TSP have now passed both the House and Senate and have been sent to the White House for its expected approval of the host bill (HR-1256). The TSP changes however would require some time to take effect even after final enactment. The most closely watched provision, mandating a Roth option in the TSP, could take upwards of two years to implement since it would require substantial changes to the TSP's operating system and agency payroll systems, plus an educational program. In a Roth option, money goes in after-tax but comes out along with its earnings tax-free, a reversal of the TSP's current design. Any money going into a Roth account would count against the overall investment dollar limit, currently \$16,500, applying to retirement savings programs like the TSP.

Concerns with our upcoming Pay Raise for Active Members

- Various bills moving in Congress have left considerable uncertainty as to the size of the January 2010 federal raise. The full House could vote as soon as this week on its version of the general government appropriations bill that by remaining silent on the raise would set an average GS increase of 2 percent, the figure requested by President Obama. The counterpart Senate bill would set the raise at 2.9 percent. Congress earlier this year endorsed parity between federal civilian and military raises, and the DOD authorization bills of both the House and Senate would set the military raise at 3.4 percent. However, language in an appropriations bill—which contains the actual money for raises—would trump the pay parity language, which was contained in a budget guidance measure that is not signed into law.

- Chapter Website. Some members don't give a hoot about websites or computers in general. If you're *not* one of those and you're wondering does anyone visit our website on the Internet, this web page may interest you. There's also a bit about our chapter newsletter The Shawnee Signal, which you're reading now.

The Bad News. Our website has a serious problem. Some members can't read our newsletter on their computer screen. And it's not the fault of their eye sight. The reason is that newsletters are posted on the website in the PDF format, and you must have a PDF reader installed in your computer to view newsletters on a computer screen. Adobe corporation developed the PDF (Portable Document Format) format, and they offer a PDF reader free on their website. Their program is named Adobe Reader. There are other sources for PDF readers, but Adobe's has become a de facto standard in the industry.

An important reason for displaying newsletters on the computer screen in the PDF format is the high cost of print copy sent by mail. Check the treasurer's report in this month's issue and you'll see the newsletter is the greatest expense for the chapter. However, the cost of displaying the newsletter in the PDF format on the computer is virtually zero.

If you can't read PDF documents you're missing the opportunity to read and save newsletters from other NARFE sources on your computer screen. There are 191 chapter websites and 42 federation websites. And they all publish their newsletters in the PDF format. So you're missing the chance to read what other chapters are up to by not having a reader.
