From the Legislative Chair:

We Are In A Hole!

Our country continues to operate without a budget. In order to avoid going over our \$14.3 trillion debt limit* which was reached in May, Treasury Secretary Geithner, began to borrow money from our solvent federal employees’ annuity trust fund (Civil Service Retirement and Disability Fund). NARFE President Beaudoin noted that the fund is strong enough to save the nation from bankruptcy. That is true only until August when according to the latest computation that fund will be empty. At that time our fund will be like the Social Security Fund with a so-called ‘lockbox’ filled with nothing but IOUs! When or if that money is put back into our fund, it will be paid back with dollars that are worth less because of increased inflation. We do not know what the chance is of getting it refilled from the general fund. This cannot be defended and neither can we continue to dig the government spending hole deeper.

* Do not confuse the debt limit with the national unfunded liability debt which is over \$200 trillion.

The federal government does not make any money; they borrow it, tax it out of the economy, or print it. It is against the law for individuals to print and spend money and when government does it, inflation is the result. For instance the U.S. Energy Information Administration said the average retail price per gallon for gas in January 2009 was \$1.83 but 2¼ years later it was \$3.44—an 84% increase. Inflation is a hidden tax on citizens.

Should we increase the debt limit and continue to borrow or should we discontinue the runaway spending that causes the debt? When more taxes are levied the job creators and entrepreneurs leave the country and find a place where it is less expensive to run a business. This hurts our economy and causes yet more unemployment.

To continue to borrow money to fund programs is to admit that the federal government is running a Ponzi scheme. Good ole' Bernie Madoff got life in prison for his Ponzi scheme which is a financial 'pyramid' operation in which new amounts of money from new investors are needed to pay off the old investors. This is what happened to the Social Security Fund some years ago; and after Treasury Secretary Geithner gets done dipping his hands into our annuity trust fund we will soon be singing the same tune. This is why most in the non-retired generation do not anticipate they will collect payments from their trust retirement fund and they would like to have the system changed.

At the end of May neither the Senate nor the President had put forward a plan to save or strengthen Medicare and it had been 761 days since they should have passed a budget. The House of Representatives opposed the President's Medicare plan partially because a panel of 15 unelected bureaucrats would decide how much, or how little, Medicare will pay doctors and which services Medicare will, or will not, pay doctors to provide for their patients. The House of Representatives' budget plan ensures that there will be no change to Medicare for those who are now 55 or older.**

The U.S. Treasury reports the national debt limit in January 2009 was \$10.6 trillion and 2¼ years later was over \$14 trillion meaning that, "We have accumulated national debt at a rate *more than 27 times as fast as during the rest of our entire nation's history.*" Since we have reached the debt limit and are out of money it seems like common sense to cut spending for programs which have no basis in the Constitution.

This document will continue to serve our country well if we remember the price that was paid for it, study the founding documents, and respect and carry out the words written in it.
