These will be evening events held at City Hall with Ann Gardner, reporter for Public TV and the Journal World, moderating. In addition, a **Candidate Fair** is planned for mid-morning Saturday, April 2<sup>nd</sup>, at Carnegie Library (9<sup>th</sup> & Vermont). Candidates will set up information booths and meet the public. Election day is April 5.

The City Hall events are awaiting Channel 6 taping crew's final confirmation. The Carnegie Library Fair needs final confirmation by the City who owns the Library. So it's close but still not final.

**FEBRUARY 16th MEETING RECAP**

Tom Kern, of the Lawrence Chamber of Commerce, presented an interesting and informative economic overview of developments in both Douglas County and Lawrence. He described projects in progress and possibilities for future development. Two current projects are Berry Plastics, producer of thermal soft plastic cups, which require less energy to produce and are more easily recycled. Berry's new warehouse and printing area will create 400 new jobs. Plasticon, Lawrence's first new manufacturing since 2000, purchased an East Hills Industrial Park building and will produce sterile vials. KU's nationally ranked #2 pharmaceutical school has developed 30% of cancer drugs in use. Research at KU is generating numerous spin-off pharmaceutical companies locating in Lawrence.

Future economic development has Lawrence, Topeka, Manhattan, K State, Washburn U, and KU partnered to develop marketing strategies to attract businesses to the "I 70 Corridor." Companies want utilities in place, a trained workforce, and good transportation infrastructure. Other possible future projects include developing farmland on east K10; multi-story retail, parking, and apartments on 8<sup>th</sup> & Vermont; and the riverfront in north Lawrence.

The Chamber needs to do a better job of educating residents of the positive effects of economic development. It also needs to address two issues: a) Lawrence's high percentage of residents with Bachelor degrees, but low percentage of those with technical training, and Douglas County is the only county in Kansas with no community college affiliation, and b) Conflicting land use views.

The Chapter brochure has been printed and 100 have been placed in a Shawnee Mission IRS branch and the Lenexa National Archives and Records Agency. Both site visits were positive and led to contacts for health fairs and more possibilities for displaying NARFE materials.

The materials include the Chapter 378 brochure, applications with a list of area NARFE Chapters, the *10 Worst Mistakes a Federal Employee Can Make* brochure, NARFE magazines, and information on NARFE's accomplishments during the 111<sup>th</sup> Congress for both active and retired personnel. The information was placed in areas that will attract employees.

Future recruiting plans include distributing information locally and focusing on educating active federal employees about the possible dangers

1) NARFE Legislative Update #748, 2/12/11

a) **Fight Back by Telephone:** All NARFE members can leverage the March 8<sup>th</sup> congressional visits of fellow NARFE members by planning a toll free call to their Congressional delegation on March 8<sup>th</sup>. Page 10 of the March NARFE magazine provides a **CUT AND SAVE feature** with complete information including a toll free number to reach U.S. Capital switchboard to reach your representative and senators and a list of things to say to the congressmen. March 8<sup>th</sup> has been designated as the day to contact your congressmen and express your concerns about the attacks on our benefits. Attendees of the NARFE Legislative Training course will be visiting Capital Hill on March 8<sup>th</sup> and NARFE is urging members to call their congressmen that same day. **Check your MARCH NARFE MAGAZINE for complete information and the "Cut and Save" on pg. 10.**

4) Quarterly News for NARFE Leaders Vol, 8 No. 1, January 2011, pg 3: *Some NARFE members may receive a letter from the U.S. Treasury urging them to sign up for either **Direct Deposit or Direct Express**. A provision of the Debt Collection Improvement Act of 1996 required the Treasury Department to stop issuing paper checks to federal beneficiaries.*

*The Direct Deposit method has been available for many years, but more recently the Treasury Department launched the Direct Express program. This program, originally available only to individuals receiving Social Security and SSI benefits who did not have bank accounts, is now available to federal annuitants. The Direct Express program features an account into which benefits are deposited, and a Debit Master Card is issued. To have access to the deposited benefit payments, the individual uses the Debit Master Cards at ATMs to withdraw cash and to pay bills.*

*The handwriting is on the wall—soon, all recipients of federal benefits will be required to either have their benefits sent by Direct Deposit or use the Direct Express card.*
