The good news is, the COLA has been calculated with 3.8 % for federal retirees and Social Security; 2.8 % for FERS retirees.

The bad news is, the Select Committee of Twelve have reached, unofficially, impasse. One group adamantly opposes any more draconian cuts to Medicare and retirement benefits. The other side refuses to consider tax increases in any form, and further cuts for defense contractors, woops ! Department of Defense are also, off the table. How that plays out when the deadline is reached without a consensus on how to achieve the \$ 1.5 TRILLION savings is the question. The choices for the Select Twelve place them in the difficult position of offending their largest contributors by cutting their profits or offending the workers and those wanting to work, plus retirees by cutting, or eliminating their benefits, who pack a large voting bloc. It is not a pretty picture to contemplate.

Letters should be addressed to the local office, and either mailed or hand delivered. ( Hand delivered, no chance for the letter to be " lost in the mail.) Federal, State, County, and City jobs have been being eliminated. I would like to encourage you to tell people and US Senators and US Representatives what your job was in the Federal Government and how important it is to have Federal Workers.

I continue to check the Committee Meetings at the State Level. There is a KPERS Meeting scheduled for the 26th and 27th of this month. They will start the ninety-day session in January of 2012 and this may include some tax proposals by the governor.

The next cost of living will be posted October 19, 2011, and this will determine if we get a cost of living next year unless it is eliminated by congress. The cost of Medicare will probably be increased.

I would like to encourage you to contact your retired friends that are not NARFE Members and let them know that we are going to have the Representatives from Blue Cross and Blue Shield and GEHA present at our next meeting on Oct. 28th to answer questions.

2011 Open Season for Health Benefits, Dental and Vision Insurance and Flexible Spending Accounts (employees only) will go from Nov. 14 to Dec. 12.

Included in NARFE top 20 Worst Mistakes are failing to have 5 years of FEHBP coverage before retiring. Losing your FEHBP coverage for your spouse when he/she has a non-federal health plan. If you elect to have a self-only FEHBP enrollment, your spouse will not be able to retain that coverage in the event of your death.
