January Meeting - Met at the United Methodist Church in Osawatomie at 11:30 a.m. There were 23 in attendance. Diana Burnett from the extension office presented a program on "Getting Organized - Keep It Or Toss It." We have \$619.01 in the Treasury. Robert Hodge gave a lengthy report on

Sympathy - Our heart felt sympathy is extended to Gerald and Doris Elwood whose son Patrick passed away January 1 in Branson, MO.

Illness - Karen Browning fell and broke her leg and had to have a rod put in it. Jean Nickell has been dealing with some health problems and Darrell Williams had to get his pacemaker rewired. We hope they all are doing better.

Legislation - Robert Hodge reported 441 members in House and 13 new Senators were sworn in. This year's budget expected to reach \$14.3 trillion. The national office wants to consider getting in touch with new representatives to get acquainted and understand where we are coming from and where they might help us. They didn't like the budget they had so passed a continuing resolution until March 4. Are working on a bill which includes a 1.4% pay raise for military personnel. Puts a freeze on federal civilian salaries. Because of new people coming in the bills will have to be reintroduced with new identity numbers. Can use CAPWIZ site for connection to send to your representative or senator. Also information on proposed payroll tax holiday. Are excused from paying tax on part of Social Security because of all this going on.

A package the house passed, 277-148, was the \$858 billion tax package passed by the Senate, 81 to 19, and signed by the President included a two-year extension of the Bush-era tax cuts and a one-year two percent Social Security payroll tax holiday. Also impact on FERS employees who don't have Social Security. If reduction in Social Security money differs has to be paid by FERS employees. Top ten legislative accomplishments by 111th Congress includes a \$250 refund tax credit for 2009 tax year. Defeating the amendment would have cut federal civilian retirement and/or health benefits by 10 billion dollars over 10 years. Got the ball rolling on re-employment of federal retirees on limited part-time basis without affecting their annuity. On retirement FERS workers will be able to credit half of unused sick leave in 2013 toward retirement and all in 2014. CSRS people can phase down part time status without affecting their final annuity. Locality pay will be creditable for retirement also. Health Care Reform - were afraid they would bring a bunch of people into our system but it was dropped.

NARFE's president has denounced the unprecedented assaults on the earned compensation of federal workers and annuitants in the final report voted on December 3 by the National Commission on Fiscal Responsibility and Reform.
