Chapter and federation officers should continue to organize and conduct congressional candidate forums as part of "Meet the Candidates" Month, to engage as many NARFE members as possible in district wide forums where incumbents and challengers are invited to address NARFE issues.

5. New members open the door for more prospective members. A new member now becomes a NARFE recruiter. If they become an informed member and realize the importance of NARFE, they will in turn talk to fellow workers or retirees that they know to join.
