From The President's Desk

Ron Richey has been working almost double shifts at the State House. I and Ron Neis help when we can by splitting committee assignments. The House and the Senate have exchanged bills and each body will hold hearings on those they have questions about, or require more information before giving approval. KPERS retirees and still working state employees have been made aware that their retirements, contributions, funding and retirement formula are being questioned and strict changes have been proposed.

We're watching KPERS issues very closely because our state income tax exemption has been brought up for discussion. As said before, the " ENVY FACTOR " is being actively promoted by corporations and groups who don't like public and federal employees or retirees. These groups have been successful at tearing down salaries and benefits for the private sector instead of sharing a little of their obscene profits (my term) with the employees who make their businesses prosper. Now they are turning to us. Instead of building their employees wages and benefits to a higher level, their new mission is to tear us down.

I studied Labor Law and Labor-Management Relations at Kansas State University and our Professor stressed the importance of a balance of power. That balance is badly skewed in favor of the very wealthy, who want even more, even if it means the destruction of the middle class.
