**Eddie Acosta, 1<sup>st</sup> Vice President, Alzheimer's**

At the Overland Park Senior Quest event I got a copy of an explanatory statement of health care reform and what it means to Medicare and seniors. I'll make copies of this statement available at the next meeting. In the meantime, Alzheimer's research must go on! I wrote up an article that will be included in my church's newsletter. This will come out next month and I'll copy it when it does.

I announced that November is Alzheimer's awareness month. If you would like to make a regular or memorial donation you may send it to me at **5216 Bond, Shawnee, KS 66203**. When you attend our regular monthly meeting you will be introduced to the "Pocket Change for Alzheimer's". This is a special canister that we circulate for the benefit of Alzheimer's Disease Research.

**Legislative Achievements**

At the 2010 National Convention, Dan Adcock National Legislative Director highlighted some NARFE legislative achievements, which included the following:

- Equity for federal retirees in the economic stimulus bill with a \$250 refundable tax credit for the year 2009 for retirees not eligible for Social Security
- Defeat of a budget amendment to cut federal civilian retirement and/or health benefits by \$10 billion over 10 years.
- Enactment of several civil service improvements including authorization for federal agencies to re-employ federal retirees without offset to annuity.
- Ability for Federal Employees Retirement System workers to credit unused sick leave toward retirement as their Civil Service Retirement System (CSRS) can.
- Permission for CSRS employees to work part time at the end of their careers without reducing their final annuity.
- NARFE helped push back four attempts to deny Federal workers a 1.4% salary increase for 2011.

As you can see from the achievements listed above, NARFE has been able to attain some very significant achievements over the past term helping both active employees and retirees. So as you talk to active employees or other retirees who are not members of NARFE, you can give them a number of good reasons why they should be a member and support the efforts of our organization. Who else is going to help fight to maintain your benefits? As of this date, we have not lost a benefit since 1993, and much of that can be attributed to NARFE's efforts on the behalf of retirees and active employees.

### From the Legislative Chair – Louis Bornman

I hope you all researched your candidates well and got a good feeling for where they stand on issues that are most important to you. I also hope that you took advantage of the many opportunities to vote early either in person or by mail. Now it's time to see what the results of the election bring. Prepare to write and email your representative and senator, whoever they might turn out to be, to voice your concerns on the key NARFE issues as the old congressional session comes to an end and the new congress prepares to start up in 2011. Remember that your voice matters, but to matter it has to be heard.

**Lame Duck Legislation Might Omit Public Sector Retirees:** The House leadership is eager to consider legislation after the November 2<sup>nd</sup> election to provide a \$250 payment to Social Security beneficiaries. It is unclear whether the over 1 million federal, state & local government retirees not eligible to receive Social Security benefits and facing higher Medicare premiums would be eligible. Remember, during the consideration of the 2009 Stimulus bill, over 1 million public employees were initially excluded from a \$250 payment to Social Security but through NARFE's efforts, a \$250 refundable tax credit for public service retirees was included in the legislation which became law. Margaret Baptiste in a NARFE October 22nd Hotline Message urged each NARFE member to contact his or her Congressional delegation to urge them to include retirees from the public sector in any "in lieu COLA" payment likely to be considered during the mid-November lame duck session.

Now is the time to use the NARFE Legislative Action Center to easily send your Representative and both Senators a prepared letter. **NARFE's toll free switchboard, 1-866-220-0044** makes it easy to call your Representative and 2 Senators, as you can ask for any Representative or Senator by name. When doing so, tell your Congressional delegation the following: *"I urge you to include federal, state and local government retirees who are not eligible for Social Security in the \$250 payment to seniors."*

**Dues Increase:** Based on the approval at the National Convention, effective January 1<sup>st</sup>, dues for a new member joining will increase from \$33 to \$45, so if you know of any potential member, now is the time to encourage them to join before the dues increase takes effect, as you can offer a chance to join at the lower rate. In addition, the convention delegates also voted in an increase to annual National Dues to take effect in 2011 of \$40 for one year, \$72 for two years and \$102 for three years. Or an annuitant can pay only \$34 per year under dues withholding, so if you're an annuitant not currently under dues withholding, when renewing, it really pays to consider the dues withholding option. (Note these amounts reflect only national dues, chapter dues will be added to these amounts.)

Now is also the time to consider becoming a Life Member as the Life Member dues will go up after January 1<sup>st</sup>. Before January 1<sup>st</sup> those dues will be based on \$33, after January 1<sup>st</sup>, they will be based on \$40, so something to consider. For example someone aged 66-70 would pay \$452 before January 1<sup>st</sup>, and \$653 after January 1<sup>st</sup>.
