### 2011 NARFE Photo Contest Calendar

The photo contest is open to all NARFE members, even those whose photos have been used in previous NARFE Photo Contest Calendars. But only the work of amateurs will be accepted.

Now, there are new guidelines for submitting photos. All photos

must be 8" x 10" horizontal size. Each entry must have the following information on a piece of paper stuck or taped to the back of each photo: name of photographer, address, chapter number, and phone number or e-mail address. Photos can be whatever you think makes a good picture, however, no photos of pets or children. Neither e-mail or Polaroid pictures will be accepted. Please limit your photos to no more than five. The photos will not be returned.

### Census Bureau Hiring for 2010 Census

The Census Bureau is now recruiting for the 2010 U.S. Census. The Census Bureau estimates that it will hire up to 1.4 million individuals to help in this undertaking. If you are interested in applying, call the toll-free jobs line at 866-861-2010 where you will be routed to your local Census Bureau Office. You can also visit [www.2010censusjobs.gov/](http://www.2010censusjobs.gov/). You can prepare by downloading the Census Practice test from the Web site.

A waiver has been granted allowing individuals who are receiving federal annuities to work in certain jobs without an offset to their salaries. This is **not** a blanket waiver for all Census positions, so when you contact the Census Bureau, find out if the position you are applying for is covered under the waiver.
